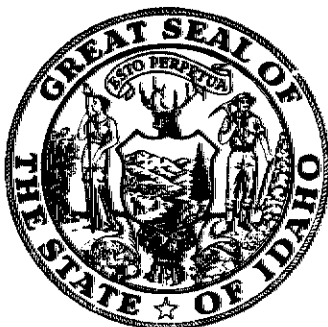

OF
SALMON HOME OXYGEN, INC

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, representing two-thirds (2/3) vote of the members of the Salmon Home Oxygen, Inc., an Idaho corporation ("Corporation"), under and pursuant to the provisions of the corporation laws of Idaho, and the acts amendatory thereof and supplemental thereto, do hereby amend the articles of incorporation of Salmon Home Oxygen, Inc as follows:

1. NAME. The existing name of the corporation is Salmon Home Oxygen, Inc. The name shall be changed to Hearthside Medical, Inc.
2. AMENDMENT TO ARTICLES. ARTICLE I of the Articles of Incorporation of Salmon Home Oxygen, Inc is hereby amended to change the name of the Corporation from Salmon Home Oxygen, Inc to Hearthside Medical, Inc. by deleting the existing Article I and inserting in its place the following:

ARTICLE I



The name of the corporation shall be Hearthside Medical, Inc.

ARTICLE III

The purpose or purposes for which the corporation is organized are to conduct a retail rental medical equipment business and to engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

3. DATE OF ADOPTION. The number of shares voted, of the members of the Corporation, for the above referenced amendment was 1,000; the number of shares voted against such amendment was 0, effective the 24th day of March, 1995
4. ARTICLES TO REMAIN EFFECTIVE. Except as amended hereby, the articles of incorporation remain unchanged and are and shall remain in full force and effect, and, together with the amendment enunciated herein, supersede the original and any supplemental articles of incorporation of Salmon Home Oxygen, Inc.
