## Articles of Incorporation

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, being a natural person of legal age and acting as incorporator of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

### FIRST:

The name of the Corporation is John Brookhart CPA PA.

### SECOND:

The period of its duration is perpetual.

### THIRD:

The purpose or purposes for which the corporation is organized are: accounting and all other purposes allowed by the Idaho Business Corporation Act.

### FOURTH:
