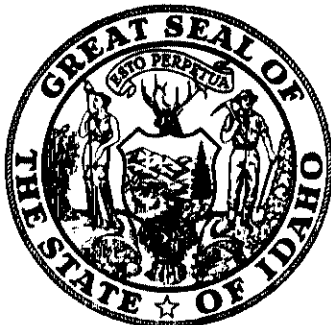

ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
SAWTOOTH ENTERPRISES, INCORPORATED

Pursuant to the Idaho Business Corporation Act, all the directors of Sawtooth Enterprises, Incorporated, hereby adopt the following Articles of Amendment of its Articles of Incorporation.

1. NAME OF THE CORPORATION. The name of the corporation is Sawtooth Enterprises, Incorporated.

2. ADOPTION OF AMENDMENT. Paragraph Number 4 of the Articles of Incorporation is amended in its entirety to read as follows:

4. Stock. The Corporation shall have the authority to issue two classes of common stock, one hundred thousand (100,000) shares of voting capital stock, all of one class, one dollar (\$1.00) par value, and one hundred thousand (100,000) shares of voting capital stock, all of one class, one dollar (\$1.00) par value.

3. DATE OF ADOPTION OF AMENDMENT. The date of the adoption of the Articles of Amendment by the directors of the corporation is June 14th, 1993.

4. STOCK. No shares of stock have been issued by the corporation.

5. EFFECT ON STATED CAPITAL. The amendment does not effect a change in the amount of stated capital of the corporation.
