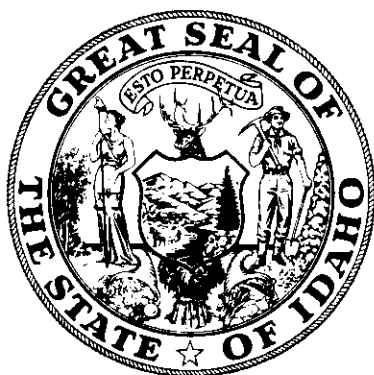

## ARTICLES OF INCORPORATION

PARENT POWER ON DRUG AND ALCOHOL ABUSE INC.

WE THE UNDERSIGNED, for the purpose of forming a non-profit corporation, under and pursuant to Title 30, Chapter 3, section 323, of Corporation Laws of the State of Idaho, 1979, and the amendments thereof, do Hereby Associate Ourselves, as a non-profit organization, and do Hereby Adopt the following Articles of Incorporation:

### ARTICLE I.

THE NAME of the Corporation shall be:

PARENT POWER ON DRUG AND ALCOHOL ABUSE. INC.

### ARTICLE II.

THE PURPOSE of the Corporation shall be:

To inform and educate parents, children and communities on the problems of drug and alcohol abuse.

### ARTICLE III.

TO ACCOMPLISH THIS PURPOSE the Corporation may do what it deems necessary, in the way of fund raising activities, and may perform such acts, as are necessary, to raise capital needed for the maintaining of interests and property.

### ARTICLE IV.

THE PRINCIPLE PLACE OF BUSINESS shall be Shoshone County, Idaho, but not limited to that place of business.

### ARTICLE V.

THE EXISTENCE of the Corporation shall be perpetual.

ARTICLE VI.

ARTICLE VII.

THE NAMES of the Executive Board of Directors shall consist of the aforementioned Incorporators, under Article VI..

ARTICLE VIII.

THE MEMBERSHIP of the Corporation shall be open to the local community and shall not be limited.

ARTICLE IX.

THE AFFAIRS of the Corporation shall be conducted by the Board of Directors and by the Officers. The Board of Directors will be elected by simple majority by the Membership on a yearly basis. The officers shall be appointed by the Board of Directors for a term of one year.

ARTICLE X.

THE REGISTERED OFFICE shall be 106 Kellogg Ave. P.O. box 832, Pinehurst, Id. 83850. THE REGISTERED AGENT shall be Donna Jones.

ARTICLE XI.

STOCK: This Corporation is formed without capital stock. Each member in good standing shall have an equal vote on all matters and at no time shall any member, officer or member of the Board of Directors, be considered an owner of any or all of the assets of the Corporation. Should a dissolution occur, no profit or part of any or all of the assets may inure to any member, officer or member of the Board of Directors. The intent of this Corporation shall be as defined in Article II and at no time shall any asset or profit, pecuniary or otherwise, inure to any member, officer or member of the Board of Directors.
