

Pursuant to Sections 30-1-59 through 30-1-62 of the Business Corporation Act of the State of Idaho, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

I.

The name of the Corporation is METAL WEST MANUFACTURING, INC.

II.

In compliance with Section 30-1-59, Idaho Code, the shareholder of the Corporation consents to the amendment of the Articles of Incorporation as appears below on the 20th day of December, 1989.

III.

The Articles of Incorporation are hereby amended as follows:

ARTICLE ONE NAME OF CORPORATION
