Specialty Construction Company, a corporation organized under the laws of the State of Idaho, filed herein its voluntary petition for dissolution. The petition came on regularly for hearing this 5th day of August, 1971. Petitioner appeared by counsel, Claude Marcus. No party appeared in opposition thereto. Evidence was submitted in support of the petition and from the evidence submitted the Court finds as follows:

1. Specialty Construction Company is an Idaho corporation having its principal place of business at Boise, Idaho.

2. June 25, 1971, Specialty Construction Company filed herein its Petition for Voluntary Dissolution and thereafter notice of said Petition for Dissolution was published in The Idaho Statesman, a daily newspaper printed and published at Boise, Ada County, Idaho, in five (5) consecutive weekly insertions and the period of publication complies with the requirements of the

Idaho statutes relating thereto.

3. No objections to the Petition for Dissolution have been made or filed herein and the Court has jurisdiction.

4. All debts and obligations of Specialty Construction Company have been satisfied and discharged and the corporation may be dissolved. Now, Therefore,

IT IS HEREBY ORDERED, ADJUDGED and DECREED that said Specialty Construction Company, an Idaho corporation, should be and hereby is dissolved as allowed and provided under the statutes of the State of Idaho.

IT IS FURTHER ORDERED that a certified copy of this Decree be filed in the office of the Secretary of State of the State of Idaho and in the office of the County Recorder of Ada County, Idaho, in which the said corporation has owned real property.
