

laws of the State of California, hereby executes the following
Articles of Merger:

1. The following is a copy of a resolution of the Board of Directors of PRIDE OIL WELL SERVICE COMPANY adopted on January 5, 1981:

"RESOLVED, that Pride Oil Well Service Company merge and it hereby does merge into itself Sierra Production Service, Inc. and assumes all of its obligations; and

"FURTHER RESOLVED, that the proper officers of Pride Oil Well Service Company be, and they hereby are, directed to make and execute Articles of Merger setting forth a copy of the resolutions to merge Sierra Production Service, Inc., and assume its liabilities and obligations as of the date of adoption thereof, and to cause the same to be filed with the Secretary of State and to do all acts and things whatsoever, whether within or without the State of Texas, which may be in anywise necessary or proper to effect said merger."

#### AGREEMENT OF MERGER

A California Corporation

INTO

PRIDE OIL WELL SERVICE COMPANY,

A Texas Corporation

This Agreement of Merger is entered into between Pride Oil Well Service Company, a Texas Corporation ("Surviving Corporation") and Sierra Production Service, Inc., a California Corporation ("Disappearing Corporation")

- 1. Disappearing Corporation shall be merged into Surviving Corporation, with the latter as the surviving corporation.
- 2. The outstanding shares of Disappearing Corporation shall be cancelled and no shares of Surviving Corporation shall be issued in exchange therefor.
- 3. Disappearing Corporation shall from time to time, as and when requested by Survivng Corporation, execute and deliver all such documents and instruments and take all such action necessary or desirable to evidence or carry out this merger.
