

#### ARTICLES OF INCORPORATION

OF

W. H. FIELD CO., INC.

KNOW ALL MEN BY THESE PRESENTS: That we the undersigned, all of legal age and citizens of the United States of America and residents of the State of Washington, being desirous of forming a corporation for the purpose hereinafter specified and in conformity to the laws of the State of Washington, do make and subscribe the following written articles of incorporation in triplicate:

#### ARTICLE I

The name of this corporation shall be "W. H. FIELD CO., INC."

ARTICLE II

The purpose of this corporation is:

- (a) To conduct a general brokerage, agency and commission business for others in the purchase, sale and management of real estate for others and the negotiation of loans thereon; to purchase and sell for others personal property, stocks, bonds and notes, and to negotiate loans thereon for others, to act as trustee in deeds of trust or mortgages on real or personal property or any evidences of value to secure them, and to act as agents for letting houses, lands, and the collection of rents and the payment of taxes.
- (b) To engage in the business of making investments and selling investments increal estate and personal property.
- (c) To purchase, hold, sell, improve, subdivide, plat, and lease real estate, and mortgage and incumber the same and to erect, manage, care for and maintain, extend and alter buildings thereon; to borrow and loan money on real estate and other security, to do a general insurance business; and to perform any and all other powers necessary, incident or convenient to the business aforesaid.
- (d) To make, perform and carry out contracts pertaining to the business aforesaid, this Corporation n with any person, firm, association or corporation, and to borrow or raise money within limits established by the board of directors by the issuance of any negotiable instrument or otherwise.

- (e) To engage in any other business in any manner reasonably connected with the businesses herein enumerated.
- (f) This enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms of the general powers of this corporation. The above granted powers are in furtherance and not in limitation of the general powers conferred by the law upon corporations.

#### ARTICLES III

The time of existence of this corporation shall be perpetual.

#### ARTICLE IV

The location and post office address of its registered office in the State of Washington is at 527 West First Avenue, Spokane 8, Washington, and its principal place of business shall be in the County of Spokane, State of Washington.

#### ARTICLE V

The authorized capital of this Corporation shall consist of \$25,000.00 divided into two hundred and fifty shares of common stock with a par value of \$100.00 per share.

### ARTICLE VI

The amount of paid-in capital with which this Corporation will commence business is \$2,600.00.

#### ARTICLE VII

The number of the trustees of this Corporation shall be four and the names of the first directors and trustees and their post office addresses are:
