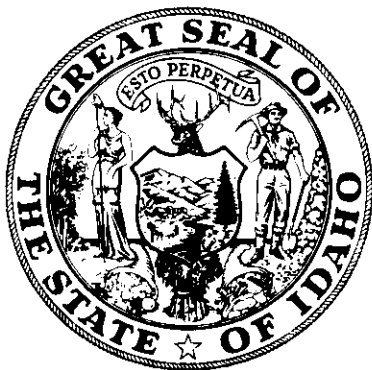

ARTICLES OF AMENDMENT

Amendment of the Certificate of Incorporation of  
the Elmore County EMS Association Inc., a nonprofit corporation organized under the laws of the State of Idaho, executed by Jim Bledsoe, of Elmore County, its President;

The corporation, on the proposal of its Board of Trustees (Directors) and Members by Formal Resolution duly adopted the said Board of Trustees (Directors) and Members setting forth the proposed amendment and directing that the same be submitted to a vote of the members entitled to vote in respect thereof at a designated meeting of such members, and on adoption thereof by said members at said meeting as provided by law, does hereby, by Jim Bledsoe, its President, and Barbara Checketts, its Secretary, execute and acknowledge the following:

That the THIRD ARTICLE of the Certificate of Incorporation of the Elmore County EMS Association Inc. shall be replaced in its entirety by the following:

THIRD: The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to do any or all the things mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, viz:

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the general Corporation Law of Idaho, to

supply emergency care and transportation for sick or injured persons in and around Elmore County, Idaho.

This Corporation is organized exclusively for charitable and educational purposes within the meaning of the Internal Revenue Code, Section (c)(3).

This Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Taxes under Section 501(c)(3) of the Internal Revenue Code.

That upon dissolution of this Corporation any remaining assets after payment of all debts shall be distributed to a nonprofit fund which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

That this Corporation is not organized for profit, and no part of the earnings shall inure to the benefit of any private shareholder.

The above amendment has been adopted by a majority of the members present at a called meeting held on the 1st day of September, 1988, as required by the laws of the State of Idaho.




