ARTICLES OF INCORPORATION

OF  
MEYERDALE DEVELOPMENT, INC.

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporations Act, adopt the following Articles of Incorporation:

ARTICLE ONE: Name. The name of the corporation is MEYERDALE DEVELOPMENT, INC.

ARTICLE TWO: Purposes. The purposes for which this corporation is formed are to purchase or in any way acquire for investment, development, or for sale, lands, contracts for the purchase or sale of lands, buildings, and improvements, and any other real property of any kind or interest therein; to build, erect, construct, lease, or otherwise acquire, manage, occupy, maintain and operate buildings for any purpose, including office buildings, bowling alleys, apartment buildings, and business structures of all kinds, and to sell, convey, lease, mortgage, deed in trust, or otherwise deal with all or any part of the property of the corporation; to make and obtain loans upon real estate improved or unimproved, and upon personal property, giving or taking evidences of indebtedness and securing the payment thereof by mortgage, deed of trust, pledge, or otherwise; and to enter into contracts to buy or sell any property real or personal, to buy or sell mortgages, trust deeds, contracts to purchase, or otherwise acquire for the purpose of holding or disposing of real or personal property of every kind and description; and to draw, make, accept, endorse, discount, execute, and issue promissory notes, bills of exchange, warrants, bonds, debentures, and other negotiable or transferable instruments, or obligations of the corporation from time to time for any of the objects or purposes of the corporation without restriction or limitation as to amount; and to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

. TICLE THREE. Duration. The period of duration of the corporation is perpetual.

ARTICLE FOUR. Registered Office and Registered Agent. The address of the corporation's initial registered office in the State of Idaho is 1121 Mullan Avenue, Coeur d'Alene, Idaho, 83814. The name of the corporation's initial registered agent at such address is John McHugh.

ARTICLE FIVE. Stock. The total authorized number of par value shares of stock is 1,000,000. The aggregate par value of the total authorized number of par value shares is \$1,000,000. The corporation shall have no shares without par value.

ARTICLE SIX. Directors. The number of directors constituting the initial board of directors is four, and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualify are:




