2                                    OF

3                                    CUMMINS FARMS, INC.

4                                    KNOW ALL MEN BY THESE PRESENTS:

5                                    That we, the undersigned, all being of full age and  
6 citizens of the United States, have this day voluntarily  
7 associated ourselves together for the purpose of forming a  
8 corporation under the laws of the State of Idaho.

9                                    And we hereby certify in writing:

10                                   I.

11                                   That the name of said corporation shall be CUMMINS  
12 FARMS, INC."

13                                   II.

14                                   That the purposes for which said corporation is formed  
15 are:

16                                   (1) To acquire farm and ranch properties and other real  
17 estate, by purchase, lease or otherwise, to improve and  
18 develop the same, and thereon to plant, sow, cultivate  
19 and harvest grains, hay, forage, sugar beets,  
20 potatoes, beans, corn, seed, and all kinds of farm produce  
21 and products of the soil. To breed, raise, buy, pasture,  
22 prepare for market, exhibit, sell, and deal in live-  
23 stock of all kinds. To engage in dairying and ranching.  
24 In general, to conduct in all their several departments  
25 and branches, the business of farmers, dairymen, stock  
26 raisers, and ranchers, and to do everything incidental or  
27 conducive to the full accomplishment of the foregoing  
28 objects.

29                                   (2) To buy, sell, mortgage, exchange, lease, let,  
30 hold for investment or otherwise, use and operate, real  
31 estate of all kinds, improve or unimproved, and any right  
32

1 or interest therein. To purchase, breed, raise, produce,  
2 or otherwise acquire, invest in, own, hold, use, mortgage,  
3 pledge, sell, assign, transfer, or otherwise dispose of,  
4 trade, deal in and deal with any and all kinds of animals  
5 and agricultural products, and manufacture, produce,  
6 purchase, or otherwise acquire, invest in, own, mortgage,  
7 pledge, sell, assign, transfer, or otherwise dispose  
8 of, deal in, and deal with any and all articles or things  
9 manufactured, produced, resulting, or derived in whole or  
10 in part from animals or agricultural products of any kind,  
11 whether to be used as food or in commerce, manufacture,  
12 the sciences, the arts, or otherwise.

13 (3) To manufacture, produce, buy, sell, trade and deal in  
14 any and all types and kinds of goods, machinery, products,  
15 merchandise and personal property of every class and des-  
16 cription at wholesale or retail for and on the account of  
17 the corporation or as manufacturer, broker, factor, or  
18 agent for others.

19 (4) To enter into, make, perform and carry out contracts  
20 of every sort and kind with any person, firm or corporation  
21 or other legal entity and to acquire and take over the good  
22 will, property, rights, franchises, options and assets  
23 of every kind and the liabilities of any person, firm,  
24 association, corporation or other legal entity either wholly  
25 or in part, and to pay for the same in cash, stocks, or  
26 bonds of the corporation or otherwise.

27 (5) To purchase or acquire property, business rights  
28 or franchises or for any other object in or about its  
29 business affairs, to incur debt and to borrow and secure  
30 the payment of money in any lawful manner, including the  
31 issue and sale or other disposition of bonds, debentures,  
32 notes or other evidence of indebtedness, and to acquire

1 by purchase, gift, or otherwise, shares of its own corporate  
2 stock and cancel the same or any part thereof, or hold  
3 all or any of such stock for resale as treasury stock, or  
4 for the purpose of making stock dividends to its share-  
5 holders and to restrict the transferability of its outstanding  
6 shares to the extent reasonable necessary to protect the  
7 rights of the corporation and its shareholders in any  
8 stock purchase, contracts, or options that may be made  
9 between themselves or any of them.

10 (6) To act as surety or creditor in any and all types  
11 of engagement, including the power to execute, endorse  
12 and deliver contracts and to guarantee the prompt and  
13 faithful performance for payment of debts, notes, agreements,  
14 contracts and undertakings of any other person, firm,  
15 partnership, or corporation, and to act as accommodation  
16 co-maker or guarantor on obligations either as primary  
17 or secondary obligor.

18 (7) Without in any manner limiting any of the  
19 objects, purposes or powers of the corporation, the business  
20 or purposes of said corporation shall be from time to  
21 time to do any one or more of all of the acts or things  
22 herein set forth.

23 (8) The several subdivisions contained in this  
24 paragraph of purposes shall be construed as both purposes  
25 and powers and the enumeration thereof shall not be held to  
26 limit or restrict in any manner the general powers conferred  
27 on business corporations by the laws of the State of Idaho,

7 That the capital stock of said corporation shall be composed  
8 entirely of stock of \$100.00 par value and the authorized number  
9 of such shares of \$100.00 par value stock shall be five hundred  
10 (500). That all of said stock shall be known as capital stock  
11 and shall be nonassessable.

13 That the amount of capital stock of said corporation which  
14 has been actually subscribed is three (3) shares and that the






