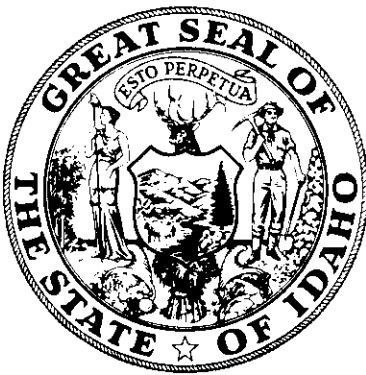

ARTICLES OF INCORPORATION  
OF  
MAGIC VALLEY FIREWOOD, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Magic Valley Firewood, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is organized for the purpose of conducting and transacting any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000; which shares shall have a par value of one-fourth dollar, (\$.25).

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the bylaws of the corporation as from time to time adopted or amended.

## ARTICLE VI

The address of the initial registered office of the corporation is Route 3, Desert View Road, Kuna, Idaho 83634 and the name of its initial registered agent at such address is John Mussell.
