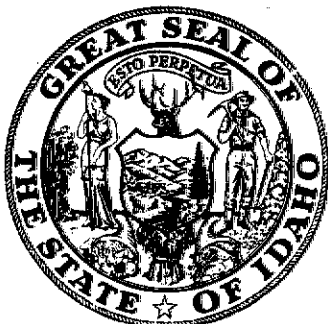

ARTICLES OF INCORPORATION
of
**CONTROL TECHNOLOGIES,
INCORPORATED**

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, being natural persons of legal age and acting as an incorporator of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST:

The name of the Corporation is CONTROL TECHNOLOGIES, INCORPORATED

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are: transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) shares, all of which shall be common shares. The par value shall be \$1.00 per share.

FIFTH:

The address of the initial registered office of the corporation is 3485 North 15th East, Idaho Falls, Idaho 83401, and the name of the initial registered agent at such address is John Price.

EIGHTH:

No director of the corporation shall be personally liable to the corporation or its shareholders for monetary damages for conduct as a director, provided that this Article shall not eliminate the liability of a director for any act or omission for which such elimination of liability is not permitted under the Idaho Business Corporation Act. No amendment to the Idaho Business Corporation Act that further limits the acts or omissions for which elimination of liability is permitted shall affect the liability of a director for any act or omission that occurs prior to the effective date of such amendment.

NINTH:


A. Indemnification. The corporation shall indemnify to the fullest extent not prohibited by law, any person who was or is a party or is threatened to be made a party to any proceeding against all expenses (including attorney fees), judgements, fines, and amounts paid in settlement actually and reasonably incurred by the person in connection with such proceeding.

B. Advancement of Expenses. Expenses incurred by a director or officer of the corporation in defending a proceeding shall in all cases be paid by the corporation in advance of the final disposition of such proceeding at the written request of such person, if the person:


1. Furnishes the corporation a written affirmation of the person's good faith belief that such person has met the standard of conduct described in the Idaho Business Corporation Act or is entitled to be indemnified by the corporation under any other indemnification rights granted by the corporation to such person and;


2. Furnishes receipts or reasonable documentation of said expenditure in a timely manner.
