know all men by These Presents: That I, the undersigned, being a natural person of full age and citizen of the United States of America, have voluntarily and do hereby associate for the purpose of forming a corporation under the laws of the State of Idaho, Idaho Code, Title 30, and I do hereby certify, declare and adopt the following Articles of Incorporation.

NAME: The name of this corporation shall be N.R.G. SYSTEMS, INC.

II.

<u>DURATION</u>: The period of existence and duration of the life of this corporation shall be perpetual.

III.

<u>PURPOSE</u>: The nature of the business and the object and purpose of this corporation shall be as follows:
