

# Articles of Incorporation

of

*Twin Groves Irrigation Company*  
*Twin Groves, Fremont Co, State of Idaho*

## Know all Men by These Presents:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

### And we hereby Certify:

FIRST. That the name of said Corporation is *The Twin Groves Irrigation Company*

SECOND. That the purposes for which it is formed are *to procure water by means of a canal for irrigation of lands and for domestic use and furnish same to its stock holders*

THIRD. That the place where its principal business is to be transacted shall be *at Twin Groves, Fremont County, State of Idaho*

FOURTH. That the term for which it is to exist is *Fifty* years from and after the date of its incorporation.

FIFTH. That the number of its Directors shall be *Five*, and that the names and residences of those who are appointed for the first year are:

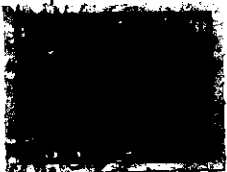
