We, the undersigned, natural persons of legal age, acting as incorporators of a Corporation under the laws of the State of Idaho adopt the following Articles of Incorporation for such Corporation:

FIRST: The name of the Corporation is: Digital Solutions, INCORPORATED

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the Corporation is organized are: assemble computers and conduct any other lawful business activity allowed under the Idaho Business Corporation Act, for which this Corporation is incorporated.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is: 100,000. Shares will be without par value.

FIFTH: The Corporation will not commence business until at least \$15,000 Dollars have been received by it as consideration for the issuance of shares.

SIXTH: Cumulative voting of shares of stock is not authorized.

SEVENTH: Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: none.

EIGHTH: Provisions for the regulation of the internal

affairs of the Corporation are specified in the By Laws of the Corporation which were adopted at the organizational meeting of the Board of Directors.

NINTH: The address of the initial registered office of the Corporation is: 657 W. Pennsylvania, Boise, Idaho 83704 and the name of its initial registered agent at such address is: Tim Trumbo.
