The undersigned acting as Incorporator of a corporation, adopts the following Articles of Incorporation for such corporation pursuant to Title 30, Chapter 21 and 30 of the Idaho Code.

**ARTICLE I
NAME**

**ARTICLE II
PURPOSE**

The corporation is a non-profit corporation and the purpose for which it has been organized are exclusively religious, charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, including the following specific purposes:

1. To assist suicidal and emotionally challenged children who are being bullied
2. To provide children and families with a retreat from emotionally challenging life and to teach and assist them to cope with these daily challenges.

MEMBERS

The corporation does not have voting members. All voting rights reside in the Board of Directors.

ARTICLE VIII
DISSOLUTION

1. Notwithstanding the provisions of the Articles, the corporation shall not carry on any activities not permitted to be carried in:
 - a) By a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended or,

- b) By a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 as amended.
2. In the event of the dissolution of this corporation, or in the event it shall cease to carry out the objectives and purposes herein set forth, all of the business, property and assets of the corporation shall go and be distributed to a nonprofit corporation qualifying as an organization exempt under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any superseding statute thereof, and as an organization qualifying as a public charity under the provisions of Section 509(a)(1) or 509(a)(2) of the Internal Revenue Code of 1986, as amended, or any superseding statute thereof, as the Trustees of the corporation may elect and designate; and in no event shall any of said assets or property, in the event of dissolution thereof, go or be distributed or be donated by such Trustees, for any such purpose. Any such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the corporation is then located, exclusively for such purposes, or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes

ARTICLE IX AMENDMENTS

Amendments to these Articles of Incorporation may be adopted by a majority of the Directors in the manner set forth in the Bylaws of the Corporation.
