ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, namely: WILLIAM T. WINE, HOMER M. DOYLE, MARVIN WEST and ROBERT FARRER, being natural persons of legal age, and citizens of the United States of America and bona fide residents of the State of Idaho, and members of a Church and religious organization, do hereby, in accordance with the rules, regulations and discipline of such Church and religious organization, associate ourselves together for the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and we do hereby adopt the following Articles of Incorporation, to-wit:

ARTICLE I.

The name of said corporation shall be "ASSEMBLY OF GOD CHURCH OF NAMPA, IDAHO. INC."

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

The location and postoffice address of its registered office and principal place of business shall be Nampa, Canyon, County, Idaho.

ARTICLE IV.

The purposes for which this corporation is formed are:

To preach and teach the Word of God; to do missionary work all over the world and general religious work everywhere;

To purchase, own, hold, sell, convey, mortgage, or otherwise hypothecate real estate and personal property of all kinds and descriptions necessary or incident to, or in connection with its church work.

ARTICLE V.

The number of Directors and Trustees for the incorporation

of this Corporation shall be four (4).

Pecuniary profit is not the object of this corporation and there is no capital stock and there are no shares of stock.

ARTICLE VIII.

CERTIFICATE

Pursuant to notice as required by law an election of the ASSEMBLY OF GOD CHURCH OF NAMPA, IDAHO, for the election of four (4) said Directors and Trustees for the incorporation thereof, was held at the Church of the Assembly of God Church, 304 16th Avenue North, in Nampa, Canyon County, Idaho, on the 1st day of March, 1944, at the hour of 8:00 o'clock P. M. of said day, and a notice of said election was duly published and posted as required by the laws of Idaho in such cases made and provided, and that the persons above named, namely: WILLIAM T.
