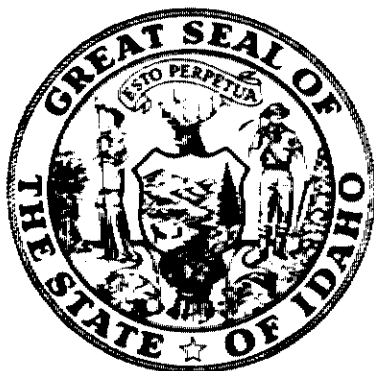



7. This dissolution has received the unanimous written consent of the shareholders, as evidenced by the Consent Minutes, a copy of which is attached hereto as Exhibit A.


