ARTICLES OF INCORPORATION

OF

P B & B INC.

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a business corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE I.

The name of this corporation shall be P B & B INC.

ARTICLE II.

The purpose for which the corporation is formed and the business or objects to be carried on and promoted by it are as follows:

- (a) To acquire by purchase, lease, or otherwise and to improve and develop real property. To erect dwellings, apartment houses, and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave, and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, and playgrounds. To buy, sell, mortgage, exchange, lease, let hold for investment or otherwise, use, and operate real estate of all kinds, improved or unimproved, and any right or interest therein.
- (b) To acquire by purchase, exchange, lease, or otherwise, and to own, hold, use, develop, operate, sell, assign, lease, transfer, convey, exchange, mortgage, create security interests in, pledge, or otherwise dispose of or deal in and with, real and personal property of every class or description and rights and privileges therein wheresoever situate.
- (c) From time to time to provide and carry out and to recall, abolish, revise, amend, alter, or change a plan or plans for the participation by all or any of the employees, including directors and officers of this Corporation or of any corporation in which or in the welfare of which the Corporation has any interest, and those

actively engaged in the conduct of this Corporation's business, in the profits of this Corporation or of any branch or division thereof, as part of this Corporation's legitimate expenses, and for the furnishing to such exmployees and persons or any of them, at this Corporation's expense, of medical services, insurance against accident, sickness, or death, pensions during old age, disability, or unemployment, education, housing, social services, recreation, or other similar aids for their relief or general welfare, in such manner and upon such terms and conditions as may be determined by the Board of Directors.

To carry on any other business or trade directly or indirectly related to or compatable with the above businesses.

- (d) To acquire by purchase or otherwise and to own, hold, cancel, reissue, sell, pledge and otherwise deal in the bonds, stocks, debentures, notes and other securities and obligations of this corporation.
 - (e) To borrow money and give security therefore.
- (f) To enter into, make, perform and carry out contracts of every kind for any lawful purposes pertaining to its business, with any individual, entity, firm, association, or corporation, or with any governmental, municipal, or public authority, domestic or foreign.
- (g) To do everything necessary, proper, convenient, or incidental to the accomplishment of the purposes and objects of this corporation, or which is calculated directly or indirectly to promote the welfare or interests of the corporation or enhance the value or render profitable any of its property or rights.
- (h) To the same extent as natural persons might or could do, to purchase or otherwise acquire, and to hold, own, maintain, work, develop, sell, assign, transfer, lease, exchange, hire, convey, mortgage, pledge or otherwise dispose of or deal in lands and leaseholds and any interest, estate and rights in real property and any person or mixed property, and any franchises, rights, licenses or privileges.

- (i) In connection with or in furtherance of any of the business of the Corporation, to make and enter into any guaranty or agreement of suretyship respecting the payment and/or performance of bonds, mortgages, debentures and other securities, contracts, obligations, interest, dividends, rents, earnings, profits, premiums, credits, payments or transfers of property of any kind.
- (j) To carry on all or any part of the foregoing objects as principal or agent, or in connection or conjunction with any person, firm, trust, corporation or other organization and in any part of the world, and in general to do any and all things and carry on any business incident to the foregoing, and to exercise all the powers conferred upon the Corporation by the laws of the State of Idaho or any other law that may be now or hereafter applicable to the Corporation, and to do any or all of the things hereinbefore set forth to the same extent as natural persons might or could do.
- (k) In general, to do any and all things and exercise any and all powers, which may now or hereafter be lawful for the Corporation to do or exercise under and in pursuance of the laws of the State of Idaho or any other laws that may now or hereafter be applicable to the Corporation.
- (1) The foregoing clauses shall be construed both as objects and powers and as in furtherance of and not in limitation of the general powers conferred by the State of Idaho; and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this Corporation.

ARTICLE III.

This Corporation shall have a perpetual existence.

ARTICLE IV.

The location and post office address of the registered office and principal place of business of this Corporation shall be 209 l4th Street, St. Maries, Idaho 83861, and the Corporation may have such other offices and places of business within or outside the

The total authorized number of par value shares is 10,000 shares of common stock having a par value of \$1.00 per share. The aggregate par value of the total authorized number of par value shares of \$10,000.00. The stock of said corporation is divided into 10,000 shares of common stock and said corporation shall issue no preferred stock or other classes of stock, and all stock issued hereby shall be non-assessable.

ARTICLE VI.

Each share of stock shall be entitled to one (1) vote.
