

ARTICLES OF INCORPORATION

Article I Name
The name of this corporation shall be the Prairie Quick Response Unit Inc.

Article II Office, Address and Registered agent
The office, address and Registered agent shall be Ed Knowles, Prairie Stage, Mountain Home, Id. 83647.

Article III Non-Profit Organization
The Prairie Quick Response Unit is a non-Profit organization, not charging membership dues, or fees for it's services.

Article IV Purpose
The Purpose of this corporation shall be to provide emergency care for ill and injured persons and to perform rescue-extrication when necessary, within the geographic limits for response as defined by the Chief of the Emergency Medical Services (EMS) Bureau, until the arrival of an ambulance that will transport the patient to a medical facility and to function as a fire protection unit, covering the same area as those agreed to with the EMS system of the State of Idaho.

Article V Board of Directors
The Board of Directors shall consist of the Executive Board of the Organization.
