- 1.) Please pay special attention to the mailing address. If it is incorrect, please make the appropriate corrections.
- 2.) **NOTE:** The name of the business entity cannot be altered on the annual report form.
- 3.) If the registered agent has changed or moved, please make that correction on this form. The registered agent must be found IN IDAHO at a PHYSICAL ADDRESS. PO Boxes WILL NOT be accepted. If report is for a Limited Liability please refer to #4 below.
- 4.) Corporation: Enter names and addresses of ONLY the president, secretary, and directors in block 4.
Limited Liability Company: Enter the names and addresses of the managers or members in block 4.
NOTE: Putting "same as last year" WILL NOT be accepted.
- 5.) Limited Liability Company: If the registered agent has been changed in block 2, then the NEW registered agent must accept that position by signing in block 5.
Corporation: Block 6 must be signed by an officer or chairman of the board of the corporation. Signer must specify his or her title.
- 6.) Limited Liability Company: Block 6 must be signed by a manager or member, who must specify his or her title.
