

ARTICLES OF INCORPORATION

OF

GREYHOUND RESCUE OF IDAHO, INC.

That we, the undersigned, citizens of the United States over the age of twenty-one years, do hereby associate ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho, and do hereby make, sign, acknowledge, file and adopt for that purpose the following Articles of Incorporation and do hereby declare:

ARTICLE I

The name of this corporation is and shall be Greyhound Rescue of Idaho, Inc.

ARTICLE II

The purposes for which this corporation is formed are:

(a) Placement of greyhounds and also to have and to exercise all rights now or hereafter granted by the laws of the State of Idaho to non-profit corporations.

ARTICLE III

The principal office of this corporation in the State of Idaho shall be located at 300 West Myrtle, Suite 100, Boise, Idaho and the name of the registered agent shall be Harold Busmann.

ARTICLE IV

The governing board of this corporation shall be called the Board of Directors which shall consist of at least 3 and not more than five members, the number to be designated by the By-Laws consistent with this article. - (c) Upon the dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code), or shall be distributed to the Federal Government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the District Court of Ada County, which is the County where the principal office of the Corporation is located, exclusively for all such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
