



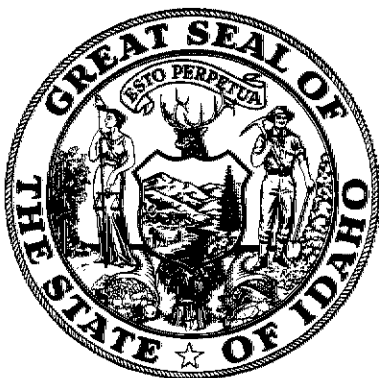
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
MICHAEL'S CONSTRUCTION, INC.

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certifies as follows:

ARTICLE I

The name of the corporation is Michael's Construction, Inc. ("Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:

1. To engage in commercial and residential construction;
and

2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The address of the initial registered office of the Corporation shall be c/o Chandler, Dillion & Allyn, Chartered, 325 West Idaho Street, Boise, Idaho 83702, and the name of its initial registered agent at such address is Linda L. Zaccheo.

ARTICLE V

The shares of stock to be issued by the Corporation shall consist of one class only, and the aggregate number of shares which the Corporation shall be authorized to issue shall be 1,000 shares of stock, each having a par value of \$1.00 per share. All shares of stock shall have the same rights in such Corporation and shall be nonassessable when paid in full.

ARTICLE VI
