ARTICLES OF AMENDMENT

OF

WESTGATE CHEVRON, INC. <sup>MA. 28</sup> <sup>6 40 AM '92</sup>

Pursuant to the Idaho Business Corporation <sup>RECORDED IN STATE</sup> Code of 1986 following Articles of Amendment to the Articles of Incorporation of Westgate Chevron, Inc. are adopted by all shareholders of the corporation:

FIRST: The name of the corporation is Westgate Chevron, Inc.

SECOND: The following amendment to the Articles of Incorporation was adopted on the 27 day of May, 1992:

Article I was amended to change the name of the corporation to Chet & Jean Ward, Inc.

THIRD: The number of shares of common stock of the corporation outstanding at the time of the amendment was 1000 and the number of shares entitled to vote on the amendment was 1000.

FOURTH: The number of shares of common stock that voted in favor of the amendment was 1000 and the number of shares that voted against the amendment was zero.

FIFTH: The remaining provisions of the Articles of Incorporation not amended herein remain in full force and effect.


