## ARTICLES OF INCORPORATION OF

THE STAR INDEPENDENT TELEPHONE COVPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS That we, the undersigned, having voluntarily associated curselves together for the purpose of forming a private corporation, under and by virtue of the laws of the State of Idaho, de therefore make and acknowledge this certificate in writing, which, when filed, shall constitute the articles of incorporation of the Star Independent Telephone Company, Limited.

Article 1. The name of this corporation shall be "The Star Independent Telephone Company, Limited ".

Article II. The purpose for which this company is organized is to build, equip and maintain at the Village of Star, Ada County, Idaho, a telephone exchange and to connect the residences of said village and the business places thereof and the residences and places of business of the surrounding vicinity with such exchange and to connect the same with lines from Boise, Meridian, Nampa, Caldwell, Pearl, Pavette, and Emmett, the whole length of such lines being 500 miles and to that end to purchase, or acquire by other lawful means, such real estate, easements, servitudes and rights and to erect and maintain such lines of poles and wires and to rent for hire telephone instruments and to do and perform such things whatsoever as may be necessary or incident to the construction, equipment and maintenance of such telephone exchange and system and to connect the same with such other telephone systems and exchanges as the company may desire so to do.

Article III. The Capital stock of this corporation shall consist of one thousane (1000) shares of the par value of Ten (\$10) Dollars each.

Article IV. This corporation shall exist for a term of fifty (50) years next after the filing of these articles.

Article V. The principal office of this corporation and the principal place of business thereof shall be Star, Ada County, Idaho.

Article VI. No person shall be a director of this corporation, or President or Vice President thereof, who is not the owner of at least \_\_\_\_\_\_ shares of the capital stock thereof.

Article VII. The holders of the capital stock of this corporation shall be entitled to cast, at all the meetings of the stockholders thereof, one vote for each share of such stock, held by the stockholder offering to vote, and such fractional part of a vote, as he shall hold fractional part of any share of such stock.

Article XIV. The Eoard of Directors shall have power to make such rules and regulations, not inconsistent with these articles of incorporation, the Ey-Laws thereof and the laws of the State of Idaho, as shall be, by such Board, deemed proper for the management and regulation of the affairs and business of the company.
