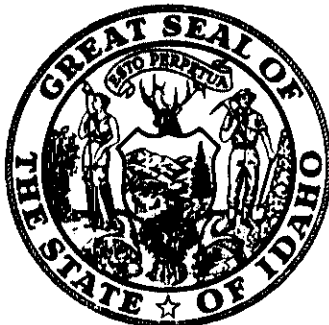

2. I, WILLIAM J. HARRIS, undersigned, being the incorporator(s), desiring to form a corporation pursuant to the provisions of the High Performance Service Corporation Act, adopt(s) the following articles of incorporation:

The name of the corporation is The O'Neill Clinic, P.A.

The purpose of the corporation is for the sole and specific purpose of rendering professional service as a chiropractor, as set forth in Idaho Code §§54-701 et seq.

The period of duration of the corporation is perpetual.

The address of the corporation's initial registered office in the State of Idaho is 1617 Lincoln Way, City of Coeur d'Alene, County of Kootenai, Idaho. The name of the corporation's initial registered agent at such address is T. Daniel O'Neill.

The total authorized number of par value shares of stock is none. The aggregate par value of the total authorized number of par value shares is No Dollars (\$0.00). The total authorized number of shares without par value is 1,000.

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than six persons. Stock shall be issued and transferable only to natural persons who are not nonresident aliens and who qualify as shareholders in this corporation as provided by the Idaho Professional Service Corporation Act.

Any additional shares to be sold or distributed by this corporation, or any portion thereof, shall first be offered, at par, to the then existing shareholders who may desire to subscribe for such stock, in relation to their then present holdings.
