ARTICLES OF INCORPORATION
OF
M.D. CONSTRUCTION CO., INC.

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE ONE

Name

The name of the corporation is M. D. CONSTRUCTION CO., INC.

ARTICLE TWO

Purposes

The purposes of the corporation are to engage in industrial construction for the construction, repairing, and remodeling of buildings and public works of all kinds; to engage in heavy equipment operation, welding fabrication, excavation, and carpentry and to engage in all acts reasonably related thereto or connected therewith and to do and perform any and all acts or things necessary, proper, or convenient for or incidental to the furtherance or the carrying out of the purposes herein mentioned.

To take any act or actions reasonably necessary or intended to promote the primary objects of this corporation, together with such other powers and purposes not inconsistent herewith as are usually had and exercised or as may be needed for the proper conduct of any business.

To have and to exercise all the powers now or hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereto.

ARTICLE THREE

Duration

The duration of the corporation is perpetual.

ARTICLE FOUR

Location
