FIRST:

The name of the corporation is SOFTNET, INC.

SECOND: The address of the initial incorporator in the State of Idaho is 7693 Birch Lane, in the City of Nampa, State of Idaho, Zip Code of 83687, County of Canyon. The name of the corporation's registered agent for service of process at such address is David Schulke.

THIRD: The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Idaho other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Idaho Corporation Code.

FOURTH: The corporation is authorized to issue only one class of stock which shall be designated common stock, and the total number of shares of stock which the corporation shall have authority to issue is One Million (1,000,000) and the par value of each of such shares is Four Cents (\$0.04) amounting in the aggregate to Forty Thousand Dollars (\$40,000.00).

FIFTH: The board of directors is expressly authorized to make, alter or repeal the by-laws of the corporation.

SIXTH: Election of directors need not be by written ballot unless the bylaws shall so provide.

SEVENTH: Section 1. <u>Liability of Directors</u>. The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under Idaho law.

Section 2. <u>Indemnification of Directors</u>. The corporation is authorized to indemnify the directors and officers of the corporation to the fullest extent permissible under Idaho law.

Section 3. <u>Non-Exclusivity of Rights</u>. The rights of conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of this Article of Incorporation, bylaw, agreement, vote of stockholders or disinterested directors, or otherwise.

Section 4. <u>Amendment, Repeal, Etc.</u> No amendment or repeal of this Article, nor the adoption of any provision of this Article of Incorporation inconsistent with this Article, shall apply to the acts or omissions of any director occurring prior to such amendment or repeal, or have any effect upon the application of this Article to such acts or omissions.
