ARTICLES OF INCORPORATION

We, the undersigned, all natural persons of full age and all of whom are citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the laws of the State of Idaho, do hereby adopt the following Articles of Incorporation.

Article I

The name of this corporation shall be WAKE PLUMBING & HEATING CO.

Article II

This corporation, when formed, shall have perpetual existence.

Article III

The location and post office address of the registered office of the corporation shall be Post Office Box 589, Blackfoot, Idaho.

Article IV

The purposes and objects of the corporation are to do a general plumbing and heating business and to do and perform any and all acts as are necessary or proper to accomplish said purposes and objects including, among others, to buy, own, sell, and lease real estate and personal property, and to install and repair plumbing and heating plants and apparatus in structures.

Article V

The amount of the total authorized capital stock of this corporation shall be \$25,000.00, divided into 2500 shares of \$10.00 par value common stock, and the rights appertaining thereto shall be in all respects equal and may be increased or decreased as provided by the laws of the State of Idaho.

Article VI
