THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is BRUNDAGE MOUNTAIN INVESTMENTS, INCORPORATED.

SECOND: The period of this duration is perpetual.

THIRD: The purpose for which the corporation is organized is: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
