I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

MINI-CASSIA BOWLING ASSOCIATION, INC.

was filed in the office of the Secretary of State on the **Fourth** day of **December** A. D. One Thousand Nine Hundred **Sixty-three** and is duly recorded on Film No. **126** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Burley** in the County of **Cassia**, and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION OF THE
MINI-CASSIA BOWLING ASSOCIATION, INC.

We, the undersigned, natural persons of the age of twenty-one years or more, acting as incorporators of a corporation, under the provisions of Title 30, Chapter 10, of the Idaho Code, do hereby adopt the following Articles of Incorporation for such corporation, and in which corporation all the rights and interest of all members in said corporation are equal, and we hereby state that no member can acquire greater interest in the said corporation than any other member.

ARTICLE I.

The name of the corporation is MINI-CASSIA BOWLING ASSOCIATION, INC., and the registered office of the said corporation is Burley, Idaho.

ARTICLE II.

The corporation shall have perpetual existence.

ARTICLE III.

The purpose for which the corporation is formed is to promote and foster the game of American Ten Pins and/or Bowling, with the assistance, guidance and direction of the American Bowling Congress by:

- A) Uniting the members of leagues, teams and individuals within the jurisdiction of the said corporation;
- B) Encouraging sportsmanship and fair play between its members and members of other bowling associations;

- C) Enforcing the rules applicable to the game of American Ten Pins and/or Bowling; and
- D) Conducting an annual local association tournament in order to determine a five-man team, two-man team, and individual and all-event championships for the area within the jurisdiction of the corporation.

ARTICLE IV.

The members of the corporation shall be all men within the jurisdiction of the corporation who qualify under the rules of American Bowling Congress and the By-Laws of this corporation, and pay membership dues required thereby.

ARTICLE V.

The control and management of this corporation shall be vested in a board of directors, an executive committee, and officers of this corporation.

ARTICLE VI.
