

Articles of Incorporation of the GRANGEVILLE BREWING COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And we hereby certify:

First.- That the name of said Corporation is the Grangeville Brewing Company Limited.

Second.- That the purposes for which it is formed are to carry on and engage in the business of brewing, malting, and otherwise manufacturing of beer; and the wholesaling and retailing of the same in barrels, kegs, bottles or otherwise, and all other business incident thereto, and to acquire real and personal property by purchase or otherwise, and to adopt such means and measures in the discretion of its management as shall seem necessary to successfully carry out the purposes above specified and allowed by law.

Third.- That the place where its principal business is to be transacted shall be in the City of Grangeville, Idaho County State of Idaho.

Fourth.- That the time for which it is to exist is fifty years, from and after the date of its incorporation.

Fifth.- That the number of its Directors shall be five, and that the names and residences of those who shall be Directors, and are appointed to manage its affairs for the first year are;
