KNOW ALL MEN By these presents, that the undersigned, being of the age of majority and citizens of the United States of America and residents of the State of Idaho, do hereby make, sign, acknowledge, file and adopt the following articles of incorporation for the purpose of establishing a corporation under the laws of the State of Idaho and for that purpose we do hereby certify in writing as follows:

1. Name. The name of the Corporation is Glen & Peggy Hotel Company, Inc.

2. Purposes. The Corporation is established for the purpose of conducting any and all business that may be conducted by or on behalf of corporations in the State of Idaho.

3. Duration. The Corporation shall have perpetual existence.

4. Authorized shares. The aggregate number of shares which the Corporation shall have authority to issue is 5,000 shares of the par value of \$1.00 each, all of one of class, which shall be designated common stock.

5. Registered office and agent. The address of the initial registered office of the Corporation is 9448 Fairview Avenue, Boise, Idaho 83704. The name of the initial registered agent at such address is Glen Black.

6. Directors. The management of the affairs of this Corporation shall be vested in the Board of Directors. The Board shall initially consist of two directors, namely, Glen Black and Peggy Black. Other qualifications of the directors, their terms of office, and manner of election or appointment shall be provided for in the Bylaws.

7. Incorporator. The names and addresses of the incorporators of this Corporation are Glen Black and Peggy Black, 9448 Fairview, Boise, Idaho 83704. Said incorporators are shareholders of the Corporation, having subscribed to 5,000 shares of the capital stock.

8. Amendments. These Articles of Incorporation may be altered or amended in any manner as provided by law.
