WHEREAS, there was issued by the Secretary of the State of Idaho, a certificate of incorporation dated the 31st day of May, 1961, constituting and creating : UNIVERSAL CHECK CONTROL, INCORPORATED", a corporation under the laws of this State with its principal place of business at 1905 Powers Avenue, Lewiston, Idaho, empowering it to engage in business as set forth in Article II of the Articles of Incorporation, and

WHEREAS, the undersigned are all of the duly elected and qualified Board of Directors of the Universal Check Control, Incorporated, do hereby certify that pursuant to due and proper notice, a meeting was held for the purpose of amending the said Articles of Incorporation as hereinafter set forth; that at the said meeting and at which said meeting all officers and directors were present, a Resolution was offered and adopted by a majority vote to amend the Charter as follows:


"RESOLVED that the Articles of Incorporation of the Universal Check Control, Incorporated, be amended to change the name of the said corporation to Universal Credit Control, Inc., and

" FURTHER BE IT RESOLVED that Article II of the Articles of Incorporation be amended by adding thereto the following; to-wit:


to engage in the business of collecting, buying, selling and dealing in current and delinquent accounts; buying, selling and dealing in personal securities, furnishing its subscribers with information in regard to the business standing of parties, the issuing of protective reports for the protection of its subscribers and patrons against parties who have had their credit impaired in various ways and bringing suit for the collection of delinquent and unpaid accounts and indebtedness. "

AND FURTHER, your petitioners certify that they have complied in all respects with I. C. 30-146 relating to the amendment of Articles of Incorporation.


WHEREFORE, they pray that the Charter be so amended.

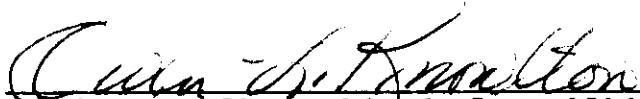
