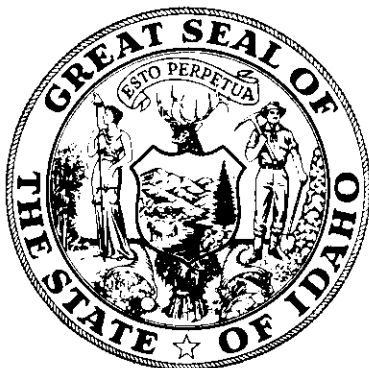

ARTICLES OF INCORPORATION

OF

AGRI PRODUCTS CORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is AGRI PRODUCTS CORPORATION.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: carrying out agricultural research, product development, sales and will, in addition provide technical services and shall be authorized to carry out all legal activities permitted to a business corporation in the State of Idaho.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand shares(100,000) having a par value of \$1.00 per share.

FIFTH: Provisions denying preemptive rights are: There are none.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: set forth in the by-laws.

SEVENTH: The address of the initial registered office of the corporation is Post Office Box 131, Twin Falls, Idaho 83301 and the name of its initial registered agent at such address is Clyde Butcher. R/O: 409 Shoshone Street
