I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

LATAH COUNTY MARINE RECOVERY UNIT, INC.

was filed in the office of the Secretary of State on the **Eleventh** day of **September**, A. D. One Thousand Nine Hundred **Sixty-two** and is duly recorded on Film No. **120** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at hoscow in the County of Latch and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

OF

LATAH COUNTY MARINE RECOVERY UNIT, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the provisions of Chapter 11, Title 30 of the 1947 Idaho Code for the State of Idaho, and acts amendatory and supplemental thereto, and we do hereby certify and declare as follows:

That we are citi ens of the United States and the State of Idaho and in pursuance thereof we do hereby sign and acknowledge the following Articles of Incorporation, in triplicate originals and state as follows:

I.

That the official name of the association ${f s}$ hall be LATAH COUNTY MARINE RECOVERY UNIT, INC.

II.

That the purposes for which this association is formed are the following:

To perfect an organization of persons of good character and understanding in the community, whose patriotism and loyalty to the government of the United States is unquestioned;

To afford recreation for and develop the physical and mental capacities and promote the health, happiness and social relations of its members on the land, on the water or in the air.

To hold demonstrations, contests, and exhibitions;

To assist the Sheriff of Latah County, or any other law enforcement officer or Civil Defense Director whenever called upon to render any service within the objects, purposes and customs of the organization; and

To carry on all similar activities except such activities deemed to be entirely political, religious, or for the advancement of a private commercial interest;

To establish, maintain and conduct a club for the social enjoyment and accommodation of members and their invited friends, and to provide a clubhouse and other conveniences, and generally to afford the members and their friends all the usual privileges, advantages, conveniences and accommodations of a club;

To purchase, lease from others and otherwise acquire, sell convey, transfer and otherwise dispose of, lease to others, mortgage or otherwise encumber real or personal property;

That the association shall have the capacity to act possessed by their natural persons insofar as permitted to do so by the laws of the State of Idaho.

To acquire by purchase, gift or any other legal manner, and to own, hold, sell and transfer and hypothecate shares of stock or bonds and other debentures of other corporations and of governments and political subdivisions thereof, and to vote the shares of capital stock of corporations while the same are held by this corporation all in the same manner as the natural person may do;

To perform every other lawful act in the furtherance of the objects of this corporation as the natural person would have the right to do.

To appoint such officers, employees and agents as the business of the corporation may require, and to allow them

compensation;

To enter into contracts or obligations of any type or kind that are essential, necessary or proper for the transaction of its ordinary affairs or for the purposes of the corporation.

III.

This corporation is not organized for profit and shall not have capital stock. No officer, director or member of this corporation shall be entitled to any of the property, moneys, dividends, earnings, funds or income of this corporation. In the event of the revocation of the Charter of the Latah County Marine Recovery Unit, located in Moscow, this corporation, on six months' notice to the members of said corporation, shall file intention of liquidation of the affairs of the corporation. Upon dissolution, any funds, property or assets remaining after the sale of said property in settlement of all debts and obligations, shall be delivered over to the County of Latah, State of Idaho through its County Commissioners to use as they shall see fit.

IV.

That the membership of this corporation shall consist of the signatories to these articles of incorporation and such other persons as may from time to time be elected to the membership of the corporation by the affirmative vote of a majority of the Board of Directors and/or in compliance with the by-laws of the corporation to be adopted. Provided, however, that the by-laws may provide for automatic expiration of and/or re-election to membership.

The time for which this corporation is to exist is not limited, but it shall exist perpetually unless dissolved according to law.

VI.

The place where its principal business is to be transacted shall be Moscow, Latah County, State of Idaho.

VII.

That the Board of Directors shall be five in number.

The method of selection and the terms of office shall be specified in the By-Laws. The names and places of residence of those who are to serve as Directors until their successors are duly chosen and qualified are:

VIII.

The Board of Directors shall have power to make, amend and repeal the By-Laws of this corporation by an affirmative vote of 2/3 of all the Directors present at any regular or special meeting of the Board. By-Laws made by the Directors pursuant to this article may be altered or repealed by a vote of 2/3 of the membership..

IX.

All of the undersigned incorporators are residents of the State of Idaho.

Χ.

That a meeting of the members of the association known as the Latah County Marine Recovery Unit was regularly

called to convene at the National Guard Armory at the Latah

County Fair Grounds in Moscow, Idaho at the hour of 8:00 p.m.

on the 6th day of August, 1962 and that a majority of the members
of said association were present.

That a notice of said meeting at which said directors were elected was published in the Daily Idahonian, a newspaper printed and published in Moscow, Latah County, Idaho, and having a general circulation therein, said notice having been published in the issues of July 21, July 28, and August 4, 1962, and that a copy of said notice was posted in a conspicuous place on the building where such election was held for the same length of time.

That a meeting of all members of the association known as the LATAH COUNTY MARINE RECOVERY UNIT was called to take place at the National Guard Armory, Fairgrounds, Moscow, Idaho, on the 6th day of August, 1962, at the hour of 8:00 p.m. That a notice of said meeting was posted at least two weeks prior to said meeting in a conspicuous place on said building, and was published once a week for three weeks in the Daily Idahonian, a Moscow, Idaho, newspaper, prior to the appointed day of said meeting.

That on said date at the aforesaid hour, a majority of the members of the association known as LATAH COUNTY MARINE RECOVERY UNIT were present and the meeting was called to order for the purposes as set forth in the posted and published notice of organizing LATAH COUNTY MARINE RECOVERY UNIT, INC., a corporation, and for the purpose of electing directors thereof.

That H. Eugene Slade presided, and Clarke E. Mitchell was the secretary-elect.

That upon a motion duly made and seconded, it was unanimously passed by those present that Latah County Marine Recovery Unit be incorporated under the laws of the State of Idaho as a nonprofit corporation.
