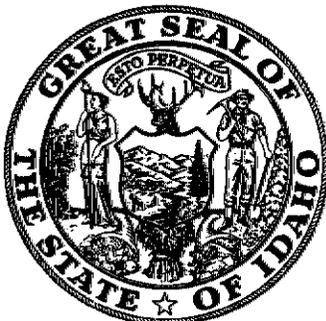

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I: The name of the corporation is ENGLISH, INC.

ARTICLE II: The purpose of the corporation is to own and operate a "Bed and Breakfast" business at 502 North Fourth Avenue, Sandpoint, Idaho, and/or other locations to be determined by the directors, and to otherwise engage in all incidental business activities related thereto.

ARTICLE III: The period of duration of the corporation is perpetual.

ARTICLE IV: The address of the corporation's initial registered office in the State of Idaho is 502 North Fourth Avenue, Sandpoint, Idaho 83864, and the name of its initial registered agent at such address is JULIE ENGLISH COIT.

ARTICLE V: The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000). The total authorized number of shares shall be without par value. The corporation is authorized to issue only one class of stock. Stock shall be issued and transferable only to natural

persons who are not non-resident aliens.

ARTICLE VI: The number of directors constituting the initial board of directors is Two (2) and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:

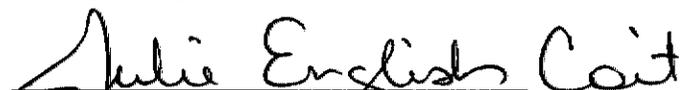

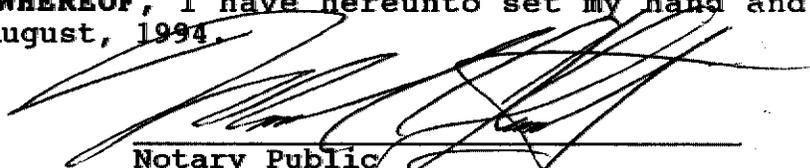
