To the Secretary of State of the State of Idaho  
Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned  
non-profit corporation amends its articles of incorporation as  
follows:

1. The name of the corporation is:

Streamliners Aquatic Recreation Incorporated

2. The text of each amendment is as follows:

Amend Article 2: The purpose for which the corporation is organized is:

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including,  
for such purposes, the making of distributions to organizations that qualify as exempt organizations under  
section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Amend Article 3: The street address of the registered office is: 1000 Shaw Mountain Rd., Boise, ID 83712  
and the registered agent at such address is: Todd Bartolome

Amend Article 4: Upon dissolution the assets shall be:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the  
meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code,  
or shall be distributed to the federal government, or to a state or local government, for a public purpose.  
Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which  
the principal office of the organization is then located, exclusively for the purposes or to such organization or  
organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
