I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that

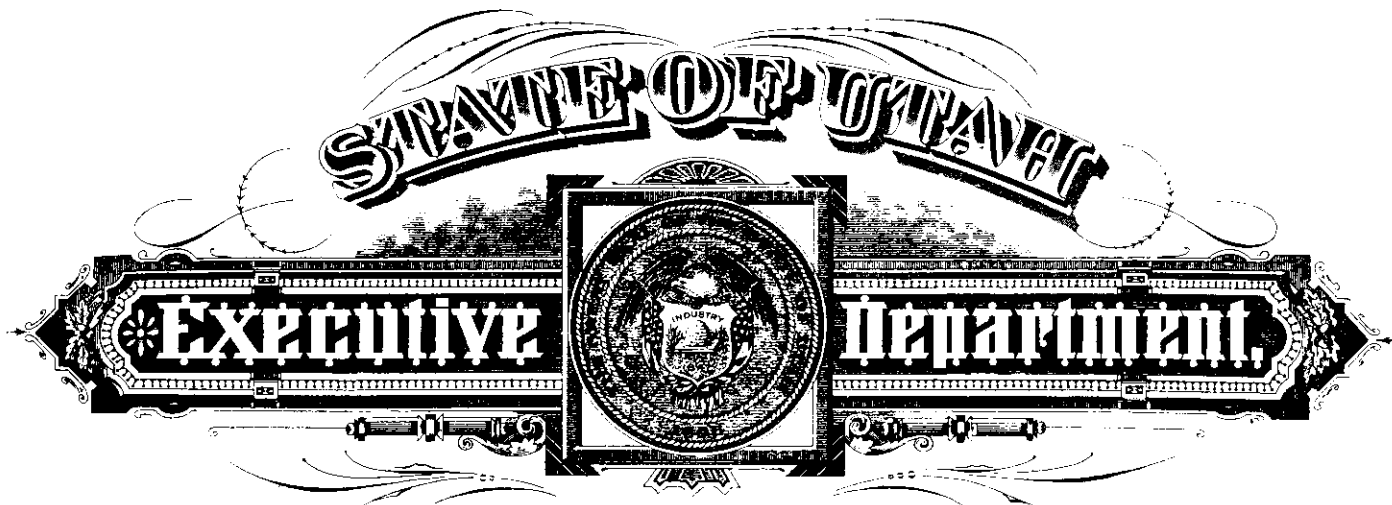

ARTICLES OF INCORPORATION

OF

AMERICAN DRIVERS MARKETING ASSOCIATION

We, the undersigned, hereby associate ourselves for the purpose of forming a corporation under the Business Corporation Act of the State of Utah, and we hereby agree to and adopt the following Articles of Incorporation and certify as follows:

ARTICLE I

The name of this corporation is American Drivers Marketing Association.

ARTICLE II

This corporation shall exist perpetually, unless sooner dissolved according to law.

ARTICLE III

The business of this corporation in general terms shall be to establish and maintain an association or club comprised of owners and operators of motor vehicles and to provide for certain services for the safety and convenience of its members. This corporation shall have all powers conferred upon corporations by the Business Corporation Act of the State of Utah.

ARTICLE IV

The total number of authorized shares of this corporation shall be 33,600, of the par value of \$1.00 per share. All of the shares of this corporation shall be common voting shares.

Any unissued shares of this corporation may be issued, allotted and sold from time to time in such amounts and for such consideration as may be lawfully determined by the Board of Directors, subject to the pre-emptive rights of the shareholders. The shares of this corporation shall be non-assessable.

#### ARTICLE V

received for the issuance of its shares.

#### ARTICLE VI

Registered      The initial Board of Directors of this corporation shall  
Office consist of three members. A quorum shall consist of two or

amendment to the By-Laws of this corporation. Until the first  
annual meeting of the shareholders and until their successors  
are elected and qualified, the Board of Directors shall consist

subject to the right of the stockholders at any general meeting  
or at a special meeting thereof called and held for that purpose,  
to alter, amend, revise or repeal the same.

#### ARTICLE IX

Directors?      No contract, act or transaction of this corporation with  
Contracts: any person, firm, corporation, partnership or association shall  
be affected or invalidated by the fact that any Director of this  
corporation is a party to or interested in such contract, act or  
transaction or in any way connected with such persons, firms,

corporations, partnerships or associations, and each person who may become a Director of this corporation is hereby released from liability which might otherwise exist from contracting with this corporation for the benefit of himself or any firm, partnership, association, or corporation in which he may be in any wise interested.

#### ARTICLE X

Power to  
Sell Assets:

In carrying on the business of the corporation, the Board of Directors is hereby authorized and empowered to sell, exchange, mortgage, bond or otherwise dispose of, deal with and encumber any and all of the real or personal property of this corporation upon such terms and conditions as the Board of Directors may deem just and proper and for the best interests of the corporation without prior authorization or subsequent confirmation by vote of the shareholders.

#### ARTICLE XI

Liability

holders:

The private property of the shareholders shall not be liable or responsible for the debts or obligations of the corporation.

#### ARTICLE XII

These Articles of Incorporation may be amended in any respect conforming to law by a vote of the majority of the issued and outstanding common capital stock of the corporation upon proper notice, at any meeting of the shareholders, whether annual or special.
