ARTICLES OF INCORPORATION

OF

RESORT CLEANING CONTRACTORS, INC.

We, the undersigned, natural persons of the age of twenty-one or more, acting as incorporators under the Idaho Business Corporation Act, and being citizens of the United States, adopt the following Articles of Incorporation:

Τ.

The name of this corporation is Resort Cleaning Contractors, Inc., and its duration is perpetual.

II.

The purpose for which the corporation is organized is to engage in the business of cleaning and janitorial services, property management, linen supply service and a general laundry. To carry out the above purpose the corporation shall have the powers as set forth in Chapter I, Title 30, of the Idaho Corporations Code.

III.

The aggregate number of shares which the corporation shall have authority to issue is 25,000 shares of One Dollar (\$1.00) par value stock. Said stock shall be non-assessable.

IV.

The location of the principal office for the transaction of the business of the corporation shall be in the City of Ketchum, Blaine County, State of Idaho. The initial registered agent is Don McCanlies.

VI.

The private property of the stockholders shall not be subject to the payment of corporate debts to any extent whatsoever.

VII.

In case a stockholder desires to sell his share or shares of stock, he must first offer them for sale to the remaining stockholders. It being the intention hereof to give them a preference to the purchase of the same and any attempted sale in violation of this provision is null and void. The stockholder desiring to sell his stock shall file notice in writing of his intention with the Secretary of the corporation, stating the terms of sale and unless the terms of sale are accepted by any or all of the other stockholders within sixty (60) days thereof, they shall be deemed to have waived their privilege of purchasing and he be at liberty to sell to anyone else upon the same terms as were offered to the other stockholders.

VIII.

The number of Directors of the corporation shall be specified in the By-Laws and such number may from time to time be increased or decreased in such a manner as is provided in the by-laws; provided, however, the number of the Directors of the corporation shall not be less than three.
