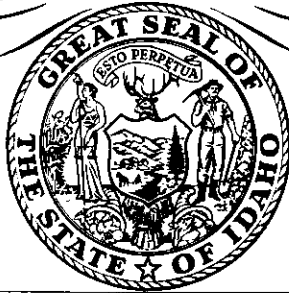

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned,
fullage citizens of the United States,
/ have this day voluntarily associated ourselves for the purpose of
forming a corporation under and pursuant to the laws of the
State of Idaho, and we do hereby certify:

I.

That the corporate name of this organization shall be
SVINGEN RAMBLER, INC.

II.

That the purposes and objects for which said corporation is
formed are as follows:

- a) To form a private profit-making corporation.
- b) To engage in a general car sale, repair and service
business within the boundaries of the State of Idaho or any
other state in the United States.
- c) To engage in any business relative to the car sale,
repair and service business.
- d) To buy, sell, exchange, encumber or carry on any
transaction with or concerning real and personal property which
will forward the proposed car sale, repair and service business.
- e) To erect any structure, structures or buildings,
necessary to carry forward the purposes above set-forth.
- f) To hire and retain workmen, laborers or any other
employees necessary for the carrying forth of the proposed car
sale, repair and service business.
- g) To issue certificates of stock in the proposed corporation,
which will be transferable upon the approval of two-thirds
of the Board of Directors.
- h) All stock certificates shall be assessable upon the

unanimous vote of the Board of Directors, providing that a notice of ninety days is given to the shareholders by registered mail to their last recorded address. Shares so assessed may be sold to the highest bidder at public sale within ten days after the assessment is due and payable, such sale shall be made at the corporate offices.

III.

This corporation shall have a perpetual existence unless sooner dissolved by a unanimous vote of the shareholders.

IV.

The location and post office address of the corporation's registered office in this state is 234 East Cameron Avenue, Kellogg, Idaho.

V.

a) The total authorized number of shares shall be FIFTY THOUSAND (50,000) shares, with a par value of ONE (\$1.00) DOLLAR per share.

b) There shall be but one class of stock.

c) Each share of stock is to have one vote at the annual shareholder's meeting.

d) The above-mentioned shares are to be sold or transferred only upon approval of a two-thirds majority of the Board of Directors.

e) This stock is assessable, as heretofore provided in these articles.
