ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION

HEREAS, The above named corporation was organized under the laws of the State of Idano, on September 25, 1957, with a capital stock of Sixty Thousand Dollars (\$60,000.00), divided into Six Hundred (600) shares of common stock of the par value of One Hundred Dollars (\$100.00) each, and,

WHEREAS, at a special meeting of the stockholders of said corporation, at which all of the stockholders were personally present, and by written assent waived notice of the time, place and purpose of the meeting, which assent was filed with and entered upon the records of the meeting before the holding thereof, and,

WHEREAS, a resolution was offered and unanimously adopted by the vote of the stockholders to amend Article V of the Articles of Incorporation to read as follows:

"The total authorized capital stock of said corporation shall be One Hundred Thousand and no/100 (\$100,000.00) Dollars, divided into One Thousand (1,000) shares of the par value of One Hundred and no/100 (\$100.00) Dollars, each, and all of said stock shall be common stock."
