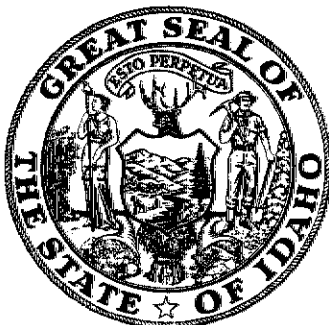

The President and Secretary of Venture Sales, Inc. report the following amendment to the Articles of Incorporation on Venture Sales, Inc.:

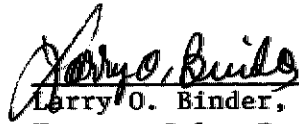
- a) Until the issuance of these articles of amendment, the name of the corporation is Venture Sales, Inc. Thereafter, it shall be Wolf Ridge Company.
- b) The shareholders of the corporation have amended the first of the articles of incorporation to read as follows:

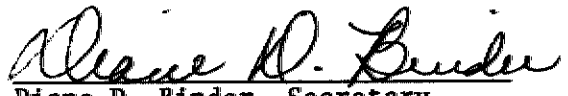

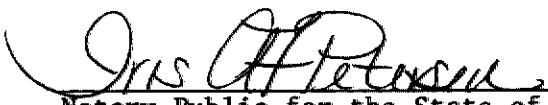

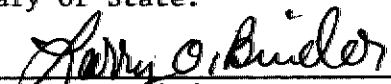
