## ARTICLES OF INCORPORATION

OF

THE FIRST WEST LATEREL OF THE BENCH CANAL.

KNOW ALL MEN BY THESE PRESENTS:-

That we the undersigned, a majority of whom are freeholders, citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify

- 1. That the name of said corporation shall be the FIRST WEST LAT-EREL.
- 2. That the purpose for which it is formed are to have and to hold real estate and personal property, to construct a canal system and all works appurtenant thereto, to construct head gates, dams and ditch es, to put in bridges, boxes and for all other purposes necessary for irrigation and agricultural purposes and for the purpose of generating power for mills and for electric power, etc.
- 5. That the place where the principle business of said corporation is to be transacted is Grace, Bannock County, Idaho.
- 4. That the term for which said corporation is to exist is (50) fifty years from and after the date of its incorporation.
- 5. That the number of Directors or Trustees of said corporation shall be (5) five and the names and residences of the Directors or Trustees who are appointed for the first year, a majority of the members being present and voting, and to serve until the election and qualifiestion of such officers, are as follows:
