RESOLUTION AND PLAN OF DISSOLUTION 15 DECEMBER 1988

THE BOARD OF DIRECTORS CONVENED IN A FINAL MEETING ON 15
DECEMBER 1988 FOR THE PURPOSE OF ADOPTING A PLAN OF DISSOLUTION
AND MAKING THE NECESSARY ARRANGEMENTS TO ACCOMPLISH IT.

A MOTION WAS PRESENTED BY D. L. PACE THAT THE ASSETS OF
THE CORPORATION BE DISTRIBUTED TO THE SHAREHOLDERS IN COMPLETE
REDEMPTION OF THEIR STOCK IN THE CORPORATION, WITH THE STIPULATION THAT THE DISTRIBUTION WAS TO BE ACCOMPLISHED ENTIRELY WITHIN
THE CALENDAR MONTH OF DECEMBER 1988. IT WAS NOTED THAT THE DISTRIBUTION WAS TO BE DONE IN THIS MANNER IN ORDER THAT IT QUALIFY
FOR TREATMENT UNDER SECTION 333 OF THE INTERNAL REVENUE CODE.

THE BOARD OF DIRECTORS UNANIMOUSLY ADOPTED THE PROPOSAL OF MR. PACE, NOTING THAT IT WAS INTENDED THAT BY SO DOING, THE SHAREHOLDERS WOULD QUALIFY FOR TREATMENT UNDER SECTION 333 OF THE INTERNAL REVENUE CODE. THE BOARD FURTHER DIRECTED THAT THE NECESSARY DOCUMENTS FOR THE DISSOLUTION BE PREPARED AND FILED WITH THE APPROPRIATE STATE AND FEDERAL AUTHORITIES.
