I, IRA H. MASTERS, SECRETARY OF STATE of the State of Idaho, and legal custodian of the records of the State of Idaho, do hereby certify that the original of the Acceptance of the Provisions of Section 30-1110, Idaho Code by

One Thousand Nine Hundred Fifty-four, and is duly recorded on Film No. 84 of Record of Domestic Corporations of the State of Idaho, and that the said Articles contain the statement of facts required by Section 30-1110, Idaho Code.

AND I FURTHER CERTIFY That the persons executing the Articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for fifty years from the date hereof, with its registered office in this State located at Boise, in the County of Ada, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.



## R E S O L U T I O N


