The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

Name

The name of the corporation is PETERSON ENTERPRISES, INC.

ARTICLE II.

Duration

The period of duration of this corporation is perpetual.

ARTICLE III.

Purposes

The purpose for which this corporation is any business which a corporation may lawfully conduct in the State of Idaho.

Likewise, this preemptive right shall apply to shares to be issued for consideration other than cash.
