VILLAGE ORDINANCES

ADJOURNED MEETING OF THE BOARD OF COUNTY COMMISSIONERS, FEBRUARY, 1892

(Com. Journal, Page 601)

Monday, February 1st, 1892. The Board met pursuant to adjournment at 10 o'clock a. m.

Present: Commissioners W. J. Pilling, Chairman; C. L. Daggett, S. L. Smith, clerk; Robt, S. Bragaw.

A petition being on file and presented to the Board praying for the incorporation of the town of Eaton, Idaho, with metes and beands to include the following described territory, to-wit: Beginning at a point on the south bank of the Kootenai river adjacent to the bridge on the county road between Eaton and Fry and run-uing thence about (1000) one thousand feet in a southwesterly direction to the northwest corner of F. Callahan's possessory right location; thence in a direction south of east for a distance of (320) three hundred and twenty rods to the southeast corner of William Eaton's possessory right location; thence in a northerly direction to the Kootenai river; thence meandering with the course of said river in a westerly direction to the place of beginning. Bounded on the west by the rayine between Eaton and Fry P. O., on the south by the possessory right location of F. Callahan and W. H. Waller, on the east by the possessory rights of D. J. Gifford, and on the north by the Kootenai river, all being situated in the County of Kootenai, State of Idaho.

The Board having duly considered said petition and having examined witnesses concerning the subject it was ordered that said petition be granted, and on motion it was ordered that the town of Eaton be and the same hereby is declared to be incorporated under the corporate name of the town of Eaton, Idaho, and that William Eaton, G. A. Thompson. Ben Morrow, A. J. Jones and Thos. J. Jones be and they are hereby appointed trustees of and for said town of Eaton as prayed for in said petition until their successors are elected and qualified. It appearing at this time that the business of the regular Japoney meeting is now finished, on motion the Board adjourned until the 2nd day of March, 1892.

Board convened pursuant to adjournment at 9:30 a.m. Present: Same as before.

In the matter of the incorporation of the village of Bonnerport, Idaho. At this time the matter of incorporating the village of Bonnerport was again taken up, and the Board having duly considered said petition and being fully advised in the premises, on motion it was ordered that the petition be granted, and that the village of Bonnerport, Kootenai County, Idaho, be and hereby is incorporated under the name and style of Bonnerport, Idaho, in accordance with the prayer of said petition with boundaries to include the following territory, to-wit: Beginning at corner No. One of Eaton townsite on the left bank of the Kootenai river, which is a post four inches square, and two and one-half feet above ground "E. T. S." 1; thence in a southwesterly direction along the northwest boundary of said townsite, about nine hundred feet (900) to corner No. 2 of said townsite, which is a tree six inches in diameter cut off six feet above the ground and squared and marked "E. T. S. 2"; thence westerly about fifty (50) feet to S. E. corner of Great Northern addition to Bonners Ferry; thence northerly along the east boundary of said addition about

one thousand (1000) feet to the N. E. corner of addition on the left bank of the Kootenai river; thence with meander along said left bank to corner No. 1 of Eatonville townsite and place of beginning, containing in all about ten (10) acres, being bounded on the north by the Kootenai river, on the southwest by Eaton townsite and on the west by the Great Northern addition to Bonners Ferry. Further ordered that James C. McRae, Fred Kaiser, G. G. Warner, B. C. Henninger and W. F. Kall be and they hereby are appointed as trustees for said village of Bonnerport (as prayed for in said petition) and until their successors are

Commissioners' Journal Regular Term, 1899. Saturday, the fifteenth day of April, 1899,

Board of County Commissioners met at 10 o'clock a. m. pursuant to adjournment.

Present: Same as before.

In the matter of the consideration of the village of Bonnerport and Eaton in Kootenai County, Idaho, and extending the boundaries and adopting the name of Bonners Ferry as the name of such consolidated village. In accordance with an act of the fifth legislature of the State of Idaho entitled "An Act providing for the Consolidation of Incorporated Cities, Towns and Villages" and containing the emergency clause. It appearing that the villages of Bonnerport and Eaton in Kootenai County, Idaho, having complied with the above mentioned act, and having filed with the clerk of the Board of County Commissioners a true copy of the ordinance of consolidation. Therefore, it is ordered by the Board of County Commissioners of Kootenai County, Idaho, that the aforesaid villages of Bonnerport and Eaton be, and the same are hereby consolidated under the name of Bonners Ferry, and that the boundary of the said village of Bonners Ferry shall embrace all the territory heretofore embraced in the villages of Bonnerport and Faton and also lot six (6) in section twenty-seven (27) of township sixty-two (62) north of range one (1) east, Boise Meridian, according to the United States survey. And it is further ordered by this Board that the date for the election of officers for the said village of Bonners Ferry be and the same is hereby fixed on Tuesday the 16th

And at this time the Board adjourned until Tuesday, April 18th, at 10 o'clock a. m.

ORDINANCE No. 1.

An Ordinance consolidating the Villages of Bonnerport and Eaton, Kootenai County, Idaho; and embracing certain territory outside of said Villages within the corporate limits of such consolidated Villages and adopting the name of Bonners Ferry as the name of such Village and stating the terms of such consolidation.

Be it ordained by the Chairman and Boards of Trustees of the Villages of Bonnerport and Eaton, Kootenai County, Idaho, in joint session assembled:

- Section 1. That the said Village of Bonnerport heretofore incorporated by virtue of an order of the Board of Commissioners for the said County of Kootenai, made on the 16th day of October, A. D. 1893, and the said Village of Eaton heretofore incorporated by order of said Board made on the 1st day of February, A. D. 1892, and under the general laws of this state, are and the territory hereinafter described, consolidated so as to form one village and one corporation.
- Sec. 2. That said consolidated village shall embrace all the territory heretofore embraced in the villages and townsites of Bonnerport and Eaton and lot 6 in section 27, township 62, north of range 1 east, Boise Meridian, all according to United States survey, said last description of land being outside of the incorporated limits of said villages, but included within the consolidated villages for the reason that it makes the boundaries of said consolidated villages more regular and the additional territory at this time receiving the benefits of such incorporation, said consolidated village being bounded by a line commencing at a point upon the south bank of the Kootenai river where the eastern line of the townsite of Eaton intersects with said river; thence in a southwesterly direction to the southeastern corner of said townsite; thence in a northwesterly direction to the southeastern corner of said townsite; thence in a northwesterly direction along the southern line of said townsite to the intersection of said line with the southern point of the Bonnerport townsite, such point being also the southwestern corner of Eaton townsite; thence in a northwesterly direction along the western line of Bonnerport townsite until such line intersects with the east and west quarter-line of section 27, township 62, north of range I east of Boise Meridian; thence west along said quarter-line to the southwest corner of lot 6 of said section 27; thence north along the west line of said lot 6 to the intersection of said (line) with the south bank of said Kootenai river; thence easterly along the south shore of said river to the place of beginning; said consolidated village embracing all the territory within the line above described.
- SRC. 3. That the name of Bonners Ferry is hereby adopted as the name of such consolidated village and it shall be known hereafter under such name.
- Sec. 4. That all the Ordinances, rules and regulations of the Village of Bonerport as heretofore incorporated shall remain in force and effect over all the territory embraced in such consolidated village.
- Sec. 5. That all records, papers and documents of the Village of Eaton, in the hands of the clerk of said village, shall be turned over to the clerk of the consolidated village, and the treasurer of the Village of Eaton shall on demand turn over all money, books, papers or records in his hands belonging to such Village of Eaton to the treasurer of such consolidated village.
- Sec. 6. That all claims, debts or demands against either of the Villages of Bonnerport or Eaton shall be assumed and paid by the consolidated village.
- i Sec. 7. That all property of every description, including all claims and demands of every description in favor of either of the two villages consolidated by this ordinance shall become the property of the Village of Bonners Ferry.
- Sec. 8. That the Board of Trustees of the Village of Bonnerport shall be deemed to be the hoard of the consolidated village of Bonners Ferry until the next annual election.

Sec. 9. That this ordinance shall take effect and be in force on and after the first day of April, A. D. 1899.

Vote of the Board of Trustees of the Village of Bonnerport on the adoption of the Ordinance consolidating the two villages: Ayes—G. R. Gray, M. W. Crane, P. B. Bothel, Julius Quist, C. W. Markle.

Vote of Board of Trustees of the Village of Eaton on the consolidation of the two villages: Ayes—S. D. Taylor, Chas. O'Callaghan, Thos. Jones, A. J. Kent.

Total ayes - 9. Total nays - None.

Ordinance was adopted.

ORDINANCE No. 2.

An Ordinance providing that the governing body of the Village shall consist of five trustees; providing for other officers of the Village; providing that the office of treasurer and collector be combined; duties of minor officers; that officers provide bond for the faithful performance of their duties; fixing amount of bond; providing time of appointment of marshal and when he must accept.

Be it ordained by the Chairman and the Board of Trustees of the Village of Bonners Ferry.

- Section 1. The government of the Village of Bonners Ferry, incorporated under the general and amended laws of the State of Idaho, shall be vested in five trustees, by whom, with the assistance and co-operation of such other officers as are provided for by the statutes of the State and ordinances of the villages, its affairs shall be administered and its laws executed.
- Sec. 2. In addition to the board of trustees, village assessor, village treasurer, village clerk, corporation counsel and village collector, as provided for by the general statutes, there is hereby ordained to be appointed annually by the Board of Trustees by resolution, a marshal and a road overseer, who shall hold office at the pleasure of the Board.
- Sec. 3. The office of collector to be combined with that of the treasurer, and that the village treasurer be, and he hereby is, ex-officio collector.
- Sec. 4. That all officers elected or appointed as herein provided for shall perform all the duties as required by the general statutes, and also such other legal duties as the Board of Trustees by ordinance from time to time may prescribe.
- Sec. 5. The village assessor, village treasurer and collector and village marshal shall file with the clerk an oath of office and an official bond, to be approved by the Board of Trustees, as required by the statutes and ordinances for the faithful performances of their respective duties, before entering upon discharge of same.
- Sec. 6. All official bonds of village officers, until otherwise ordered, shall be in the following sums, to-wit: Village treasurer and collector, \$500, and village marshal, \$500.
- Sec. 1 That all appointments of marshal shall be made as soon as the Board of Trustees shall have organized after each annual election, and such officer, when appointed, shall qualify by oath and giving bond, where required, within ten days after the notice of such appointment, or be shall be deemed to have refused to accept and another officer may be appointed in his stead, who shall in a like manner be required to qualify.
