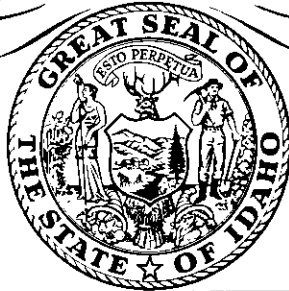

CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

CHALET AMUSEMENTS, INC.

was filed in the office of the Secretary of State on the **Twenty-sixth** day of **July,** A.D. One Thousand Nine Hundred **Sixty-three** and duly recorded on Film No. **124** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **an unlimited period** from the date hereof, with its registered office in this State located at **Caldwell** in the County of **Canyon**

5 We, the undersigned natural persons of the age of 21 years or more, a
6 majority of whom are residents of the State of Idaho and the United States of
7 America, do hereby voluntarily associate ourselves for the purpose of forming
8 a private corporation under the laws of the State of Idaho. We hereby set forth,
9 declare and certify that:

10 I. The name of this corporation is CHALET AMUSEMENTS, INC.

11 II. The purposes of this corporation are:

12 (1) To conduct, maintain, and operate the business of amusements,
13 entertainment, and recreation of the public, including any and all facilities for
14 go-carts, minature golf, trampolines, games of skill, athletic and contests,
15 and exhibitions of every nature, for participation by the public or otherwise;
16 to charge admission fees, rates, rentals, and other forms of remuneration for
17 so doing;

18 (2) To do and transact all business properly connected with or incidental
19 to any or all of the objects and purposes of the corporation, including the buying
20 and owning of the necessary equipment and facilities for the business, and the
21 buying, leasing, and conveying of real estate used in connection with said
22 business.

23 (3) To transact the business of investing on behalf of itself or others,
24 any part of its capital and such additional funds as it may obtain or any interest
25 therein, either as tenants in common or otherwise, and selling or otherwise
26 disposing of the same, or any part thereof, or any interest therein;

27 (4) To appoint such officers, employees and agents as the business
28 of the corporation may require and to allow them compensation.

29 (5) To issue shares and admit shareholders, and to engage in all
30 transactions incident to the same.

31 (6) To purchase the shares of other corporations, or to purchase its
32 own shares.

1 (7) To make accomodation guaranties, endorsements, or contracts
2 of suretyship.

3 (8) To enter into a partnership or joint venture to carry out any
4 of the business purposes for which this corporation is organized.

5 (9) To engage in any activity or to do anything with the objects and
6 purposes hereinbefore mentioned that my be necessary or proper to
7 accomplish successfully or promote the said objects and purposes. The fore-
8 going clauses, by reason of the specific enumeration of powers shall not be
9 held to restrict the power of the corporation to do any of the things within the
10 purview of its general powers.

11 III. That the duration of the corporation is unlimited.

12 IV. The location and post office address of the registered office of the
13 corporation in the State of Idaho is 601 North Florida Avenue, Caldwell, Idaho;

14 V. The total authorized number of par value shares is Three Hundred
15 and Fifty (350). The aggregate par value of the total authorized number of
16 par value shares is Thirty Five Thousand and NO/100 (\$35,000.00) Dollars.

17 VI. The stock of the corporation is divided into Three Hundred Fifty(350)
18 shares of common stock, the par value of each share shall be One Hundred and
19 NO/100 (\$100.00) Dollars and such stock shall be non-assessable.

20 At every meeting of the shareholders, every holder of the common stock
21 of the Corporation shall be entitled to one vote for each share of common
22 stock standing in his name on the books of the corporation. At each election
23 of directors, every holder of the Common Stock of the Corporation shall have
24 the right to vote, in person or by proxy, the number of shares owned by him
25 for as many persons as there are directors to be elected and for whose election
26 he has a right to vote, or to cumulate his votes by giving one candidate as
27 many votes as the number of such directors multiplied by the number of his
28 shares shall equal, or by distributing such votes on the same principle among
29 any number of such candidates.
